Michigan Economic Growth Authority FY 2022 Report to the Michigan Legislature Narrative

As required by Public Act 24 of 1995, as amended, and Public Act 122 of 1941, as amended, below are statements that address the reporting requirements for the Michigan Economic Growth Authority (MEGA) fiscal year (FY) 2022 report beginning October 1, 2021 and ending September 30, 2022.

The MEGA statute requires the report include data for each year the company claims a MEGA tax credit. The annual data represents the number of employees the company was approved to claim in each tax year and the investment represents the value of investment made by the company during each tax year, as self-reported by the company.

With the repeal of the Michigan Business Tax (MBT) and the transfer of the MEGA to the Michigan Strategic Fund by Executive Order 2012-09, there were no MEGA agreements executed in FY 2022, and with the repeal no authority exists to award new tax credits against the MBT.

In the FY 2022 reporting year, there were 25 MEGA tax credit certificates issued. All MEGA Annual Certificate Applications and supporting documentation are reviewed for compliance prior to approval. After being reviewed, approved, and issued a tax credit certificate, the company is responsible for attaching the signed MEGA Tax Credit Certificate to its MBT filing to obtain a credit or refund, depending on its tax liability, from the Michigan Department of Treasury.

As in previous years, companies were asked to include their job creation numbers even if they did not meet the MEGA requirements and did not receive a tax credit certificate. The "Did Not Qualify" (DNQ) notation on the MEGA Total Jobs & Investment Reported for Each Year report that is attached signifies that the company filed a DNQ form and reported its job creation number but was ineligible for a credit certificate. This information is submitted by the company voluntarily. The amount of capital investment made by each company is reported voluntarily for the majority of MEGAs and is a statutory requirement for MEGA Retention credits.

Companies that have received a Standard credit and a Retention credit for one project are noted in the MEGA Total Jobs & Investment Reported for Each Year report in the same tax year. It is possible for a company to collect a Retention credit and not the Standard credit. Companies that have received both credits are reported in one year on two separate lines, showing the job creation on one line and the job retention on the next line.

Although the MEGA program is a tax year program, job creation and job retention data found in the reporting is for a company's tax year, which varies among companies, rather than Michigan's fiscal year. The jobs reported for a particular year are the total jobs created and/or maintained for that tax year. Many companies receive extensions to file their MBT forms; thus, Compliance staff may receive an Annual Certificate Application for a MEGA tax credit up to four years after the company's actual tax year has ended.

As no new MEGAs were approved in FY 2022, this report does not contain information regarding corporation directors and officers of similar positions within limited liability companies, or fees, donations or other payments as this information was collected and reported in past annual reports for newly approved MEGAs.
