Michigan Renaissance Zone Act 2011 Legislative Report

The Michigan Renaissance Zone Act, Public Act 376 of 1996, established the Michigan Renaissance Zone initiative to foster economic opportunities in the state; facilitate economic development; stimulate industrial, commercial and residential improvements; prevent physical and infrastructure deterioration of defined areas; and provide for the reuse of unproductive or abandoned industrial properties.

Summary of Renaissance Zone Activity

Since the inception of the Renaissance Zone program a total of 71 Renaissance Zones have been designated exclusive of Tool & Die Recovery Renaissance Zones. Of the 71 designated Zones, there are 63 in effect. These areas are designated as free of most state and local taxes for any business or resident located within the zone. Renaissance Zone tax incentives are designed to attract various types of development, such as industrial, commercial, and residential projects. As a result of the program, local units of government have reported over 660 projects projected to result in the creation of over 10,944 jobs and over \$3.1 billion in private investment over the life of the Zones.

This report summarizes activity that occurred within Renaissance Zones during calendar year 2011. In 2011, the Michigan Strategic Fund (MSF) approved one new subzone, and recommended for approval to the State Administrative Board one new Renewable Energy Renaissance Zone and one new Agricultural Processing Renaissance Zone. The MSF approved seven time extensions extending the duration of specific parcels/portions of existing Renaissance Zone Subzones.

Geographic Renaissance Zone Activity

The Michigan Renaissance Zone Act allows for the designation of Geographic Renaissance Zones and subzones within those zones. The Act, as amended, allows for the designation of new subzones and the extension of time for one or more portions of existing Renaissance Zones. The Michigan Strategic Fund (MSF) Board was given the authority to grant new subzones and time extensions through December 31, 2011.

There are currently 21 geographically targeted Renaissance Zones covering 140 locations across the state. There are 10 urban zones, eight rural zones, and three military zones (three geographic locations). The zones are designed to provide communities with a market-based incentive of virtually no state or local taxes to encourage new jobs and investment to that area. Although there are Development Agreements for specific projects within geographic Renaissance Zones that require annual reporting, general reporting for Geographic Renaissance Zones is voluntary and results in an underreporting of activity within the zones. Communities report that it is difficult to track the businesses and residents that move into the zones.

As of December 31, 2011, companies located in Geographic Renaissance Zones reported a total of 763 new jobs and over \$86 million in private investment.

Agricultural Processing Renaissance Zones

Agricultural Processing Renaissance Zones are company-specific rather than geographically targeted. The Michigan Renaissance Zone Act originally allowed for the designation of five Agricultural Processing Renaissance Zones by the State Administrative Board. The Act was amended three times to increase the number of potential zone designations to a total of 30 Agricultural Processing Renaissance Zones.

As of December 31, 2011, the Michigan Strategic Fund (MSF) and the Michigan Commission of Agriculture (MCA) have recommended designation of 25 of the 30 available zones to the State Administrative Board pursuant to Section 8c (1) of the Act. Currently, 20 of the 25 Agricultural Processing Renaissance Zones are in effect with five of the zones revoked or no longer in effect. There are five zones available for designation.

Over 3,000 new jobs and over \$853 million in private investment have been committed within the zones over the life of the zones. Agricultural Processing Renaissance Zones are company-specific. The following companies are designated as Agricultural Processing Renaissance Zones:

Michigan Strategic Fund (MSF) Designated Renaissance Zones

The MSF Board may designate Renaissance Zones anywhere in the state as long as the city, village, or township consents to the creation of a Renaissance Zone within their boundaries. Initially, legislation allowed the MSF Board to designate five Renaissance Zones. The Act was amended in order to create an MSF Designated Redevelopment Renaissance Zone for Greenville and to increase the number of available MSF Designated Redevelopment Renaissance Zones. Further legislation has since increased the number of potential MSF Designated Zones to 27, three of which must be designated in a rural area. Additionally, legislation requires that one MSF Designated Zone must be a Pharmaceutical Recovery Renaissance Zone.

As of December 31, 2011, the MSF designated a total of 15 zones. Ten MSF Designated Renaissance Zones, one of which is a Pharmaceutical Recovery Renaissance Zone, have been designated along with five MSF Designated Redevelopment Renaissance Zones. There are 12 zones available for designation. Of the 12 available zones, two of them are required to be redevelopment zones and three must be in a rural area.

It is projected that over 6,765 new jobs will be created, 780 jobs retained, and more than \$1.8 billion in private investment will be committed during the life of the zones. The following properties have been designated as MSF Designated Renaissance Zones:

Renewable Energy Renaissance Zones

Renewable Energy Renaissance Zones are company-specific rather than geographically targeted. The Michigan Renaissance Zone Act, as amended, authorizes the State Administrative Board to designate up to 15 Renewable Energy Renaissance Zones, upon recommendation by the MSF Board. Of the 15 zone designations, five must be used for renewable energy facilities engaged in the production of cellulosic biofuels.

As of December 31, 2011, nine zones have been designated with eight in effect; three of the eight designations satisfy the requirement for the production of cellulosic biofuels. There are currently six zones available for designation and of those six; two must satisfy the requirement for the production of cellulosic biofuels. The following companies have been designated as Renewable Energy Renaissance Zones:

Forest Products Processing Renaissance Zones

Forest Products Processing Renaissance Zones are company-specific rather than geographically targeted. Section 8(f) of the Michigan Renaissance Zone Act, as amended, allows for the designation of ten Forest Products Processing Renaissance Zones by the State Administrative Board upon recommendation by the MSF Board. As of December 31, 2011, one zone has been designated and nine additional Forest Products Processing Renaissance Zones are available for designation. The following company is designated as a Forest Products Renaissance Zone:

Border Crossing Facility Renaissance Zones

The Michigan Renaissance Zone Act, as amended, allows for the designation of up to 25 Border Crossing Facility Renaissance Zones in qualified border local governmental units if the city or township or combination of cities and townships consent to the creation of a Renaissance Zone. No Border Crossing Facility Renaissance Zones have been designated and there are 25 available zones.

Next Michigan Renaissance Zones

The Michigan Renaissance Zone Act, as amended, allows for the designation of Next Michigan Renaissance Zones within a Next Michigan Development District, as defined by Section 3 of the Next Michigan Development Act (Public Act 275 of 2010). The MSF must first designate a Next Michigan Development Corporation comprised of local government units that enter into an inter-local agreement to form the Corporation. Based on the number of parties in the Corporation, the Corporation may then recommend up to 12 zones per development district to be designated as a Next Michigan Renaissance Zone. The Next Michigan Development Corporation may then submit an application on behalf of an eligible business to the MSF for the established Renaissance Zone.

An eligible business within a zone may be granted the benefits of zone status for up to 15 years. Up to 25 businesses can be certified as eligible businesses under the Act, and no more than 10 businesses can be certified in any one development district. As of December 2011, two Next Michigan Development Corporations have been designated, but no Renaissance Zone designations have been made.

Tool & Die Recovery Zones

The Michigan Renaissance Zone Act, as amended, allows the MSF Board to designate up to 35 Tool & Die Renaissance Recovery Zones in the state, to be located in cities, townships, and villages that consent to the creation of a Tool & Die Recovery Zone within their boundaries.

Tool & Die Recovery Zones are industry-based/company-specific with the purpose of encouraging collaboration among tool and die companies to help strengthen them and retain existing jobs, as well as make them more competitive in the global marketplace. To qualify for a Tool & Die Recovery Zone designation, the parcel(s) of property must be leased or owned by a qualified tool and die business and used primarily for tool and die business operations. Businesses must be classified as one of the North American Industrial Classification System (NAICS) codes listed in the law and be part of a collaborative agreement with other tool and die companies. Companies with over 75 employees may be included in a recovery zone if the company enters into a written agreement with the MSF Board and local unit of government.

As of December 2011, there were a total of 29 Tool & Die Recovery Zones consisting of 298 companies in 36 counties designated as Tool & Die Renaissance Recovery Zones.

Additional Information

Most state and local taxes, including real and personal property taxes are abated within Renaissance Zones for up to a maximum of 15 years. The tax benefits are phased out in 25% increments during the Zone's final three years of existence; however federal government taxes, local bond obligations, school sinking fund, or special assessments may still be due. Additionally, companies are not exempt from paying the Michigan sales tax.

The State of Michigan reimburses intermediate school districts, local school districts, community college districts and public libraries where taxes are abated. There is no FY 2011 appropriation for reimbursements to public libraries and community colleges unless a supplemental appropriation is approved. The State of Michigan does not replace the tax revenue lost to the local unit of government or county.
