  - iii. April 22 May 5: the Michigan Travel Commission embarked on a process to develop the new Michigan Travel Strategic Plan for the travel industry. As part of the development process, Travel Michigan invited businesses and community leaders from various travel industry sectors to attend focus group sessions via Zoom. Film Office promoted the opportunity to participate in the following focus group with film festival organizers:
    - 1. Attractions, Arts, Culture & History
    - 2. Sports, Festivals & Events
  - iv. May 5 The National Travel & Tourism Week press conference held at Frederik Meijer Gardens and Sculpture Park in Grand Rapids.
    - 1. This event was presented by the TICOM and hosted by Experience Grand Rapids in partnership with Travel Michigan, the office that manages the Pure Michigan campaign.
    - 2. As a member of TICOM, Film Office attended and extended invitation to Mosaic Film Experience and Grand Rapids Film Festival.
