Issue

Approval of the Early Stage Funding Request for Proposals

Background

As provided for in MCL 125.2088k(2), the Strategic Economic Investment and Commercialization Board ("SEIC Board") shall award grants and loans from the 21st Century Jobs Trust Fund to encourage competitive edge technologies to create jobs in the State of Michigan. Pursuant to Executive Order 2010-8 the Governor ordered the SEIC Board abolished and all powers, duties, and functions of the SEIC Board were transferred to the Michigan Strategic Fund ("MSF"), including those powers and duties and functions provided under MCL 125.2088k. The MSF Board desires to allocate up to \$13 million, disbursed over 2 to 3 years, to non-profit organizations to capitalize a fund that invests in pre-seed and start-up competitive edge technologies that require capital to transition from research to the earliest stages of the commercialization process.

Public Hearing

A public hearing was held on April 11, 2011 to allow interested persons the opportunity to express data, views, questions, and arguments regarding the proposed Early Stage Funding Request for Proposals. Six people attended the public hearing and seven written comments were received. In addition, comments at the public hearing centered on the meaning of statewide in the eligibility requirements and the financial leverage and matching requirements. Minutes of the public hearing were presented to the MSF Board at its April 27, 2011 meeting.

Decision

At its April 27, 2011 meeting, the MSF Board considered the comments received at the public hearing, and agreed that there was a need for the Early Stage Funding program. On April 27, 2011, the MSF Board approved the Early Stage Funding Request for Proposals.

WHEREAS, modifications were made to the RFP based on comments received at the public hearing held on April 11, 2011;

WHEREAS, the MSF has reviewed a RFP form, which includes provisions required by the Act and establishes a competitive proposal process for awarding grants to non-profit organizations related to Early Stage Funding. A copy of this RFP form is attached to this Resolution; and

WHEREAS, the MSF desires to initiate the competitive proposal process to award grants to non-profit organizations for Early Stage Funding.

NOW, THEREFORE, BE IT RESOLVED, that the MSF approves the attached RFP form and authorizes its issuance; and

BE IT FURTHER RESOLVED, that the MSF authorizes a Board Member, after consultation with the Attorney General and Chief Compliance Officer, to modify the RFP as may be necessary or appropriate, if the modifications are not material or adverse to the interests of the MSF.
