**SUBJECT:** Section 1030 – Minority-Owned Business Support Annual Report

Section 1030 of Public Act 121 of 2024 requires the department to award grants to minority-owned businesses or non-profit business organizations to implement small business development initiatives for minority-owned businesses in this state. Further, the department is required to provide an annual report detailing the number of awards granted, the amount of each award, the recipient and purpose of the awards until the funds have been expended, as well as any recommendations to improve the future distribution of funds to eligible entities under this section.

In FY 2024, the department awarded a total of 10 Inclusive Entrepreneurship Support Grants with funds totaling \$9,800,000.00. In FY 2025, a total of 23 Trusted Connector Grants were awarded with funds totaling \$6,800,000.00. A breakdown of the awards is attached.

In the future, the department recommends the following to improve the distribution of funds to eligible entities:

- 1. No Earmarks: Having no earmarks offers flexibility for a single application and speeds up the launch and review process, ultimately getting funds to small businesses faster.
- 2. Industry Focused Grant Funds to Support Businesses Served: Industry associations and organizations offer industry assessments and certifications (Example: ISO9001, AS9100, CMMC [cybersecurity maturity model through DoD], Safety Certifications [Construction Industry], etc.) that specifically target barriers to businesses. These certifications enhance manufacturing competitiveness and help companies reduce risks when expanding into new and adjacent industries. The businesses served through the business associations and organizations would be supported by providing them with the

essential certifications and capabilities to enter new industry sectors and diversify their products and services.
